Peggy Glass:

TDS Coalition Update: The Coalition is planning on scheduling a meeting with TCEQ in June 2019. In regards to the legislative front, the Legislatures will be in session for two more weeks.

Larry Patterson: Informed everyone about Senate Bill 29, this will impact all utilities. This bill will prohibit utilities from spending funds to influence legislation. Also there is a bill that will require Water Districts and River Authorities to either video or audio record meetings and put them on the internet.

Gordon Pederson (NACWA Update):

Informed audience about the upcoming May 22nd NACWA Water Quality Meeting. NACWA is working on responding to the PFAS and PFOS issues that are in the works. The Strategic Commination Meeting is having its annual Meeting in Cleveland Ohio starting on June 3. The NACWA National meeting will be in Minneapolis July 13 to 16. The Excellence in Management Awards closed on May 10. NACWA is also giving input to Congress for congressional funding.

Wes Kucera (NACWA Update):

NACWA has issued a press release on comments to the WOTUS Rule. Made comments and issued guidelines for PFAS, which are getting national attention. PFAS are also being found in BioSolids. NACWA also made comments on nonwoven disposable products labels (flushable wipes).
